Public Notice Property Inspections

Compass Assessment Consultants Inc. will be conducting inspections at select properties throughout the County boundaries starting, mid December 2021. Properties to be inspected are those which a development permit has been applied for, or a known change has occurred.

Property inspection is a standard policy to ensure accurate information is collected and reflected in the property assessment.

County assessors will be wearing photo identification badges. If residents are not home, assessors may leave a door hangar with information to contact Compass Assessment Consultants Inc. if

Fire Hall Spotlight: Kinuso

The Kinuso Fire District provides services to a large portion of the County, from farmland, lakefront properties, forested areas, and a large stretch of Highway 2 and Highway 33. Kinuso also neighbours Swan River First Nations and provides services to the community. With well over 100 years of service among their members, the Kinuso fire district has some of the longest-standing memberships in all of our districts. Kinuso responds to an average of 30 calls per year, ranging from MVCs, Structure fires, Vehicle Fires, Outdoor fires, and assisting search and rescue and water rescue efforts. Their fleet consists of a Fire Engine, A Rapid attack truck, a support truck, a Rescue Unit, and a side-by-side. Kinuso has training nights bi-weekly on Mondays.

WINTER HOURS

Transfer Station winter hours - October 1 - March 30

Big Lakes County Transfer Stations are open Wednesday & Sunday from 11 am to 6 pm.

The Regional Landfill is open Monday, Thursday & Saturday from 10am to 5pm.

Help keep our County clean by properly securing your load and bringing your waste to a Transfer Station or Regional Landfill.

If caught illegally dumping waste, residents can face fines. If you witness someone dumping illegally, write down as much information as you can and report it to Big Lakes County.

Please note: the Transfer Stations are closed Christmas Day. The Regional Landfill is closed Christmas Day. Boxing Day. New Years Day, and Easter Sunday.
