- Re-district Plan 1904V, Block X in the Hamlet of Grouard from the Urban Reserve District to the Hamlet Residential District.
- 2. Re-district SE and SW 13-73-11-W5 from the Agriculture District to Commercial Recreation District.
- Re-district Plan 6010AV, Block 1A in the Hamlet of Grouard from the Urban Reserve District to the Hamlet Residential District.

Winter Hours

Transfer Station winter hours will begin October 1 - March 30

Until then, Big Lakes County Transfer Stations will remain open Wednesday & Sunday from 10 am to 7 pm.

The Regional Landfill is open Monday, Thursday & Saturday from 10 am to 5 pm.

Please Note: The Transfer Stations are closed Christmas Day. The Regional Landfill is closed Christmas Day, Boxing Day, New Years Day, and Easter Sunday.

Reminders

Tree stumps and large wood debris are not accepted at Big Lakes County Transfer Stations. These items are too large to burn and must be taken to the Regional Landfill.

Branches, logs, and firewood are accepted at the Big Lakes County Transfer Stations but must be cut into 4 foot lengths.

Health Advisory: Blue Green Algae

A blue-green algae (cyanobacteria) bloom has been identified in Lesser Slave Lake, and Freeman Lake, near Swan Hills in Big Lakes County. Please visit albertahealthservices.ca/news/bga.aspx for more information.

The intent of the advisory is not to prohibit any lake activities, but to make individuals aware of the current situation, provide them with information to assess the risk of their chosen activities, and assess the condition of the lake prior to using it.

Operating & Capital Grant Deadline

Attention Community Organizations! Have you applied for the Capital and Operating Grants? Big Lakes County proudly offers a broad range of funding opportunities to our community organizations whose activities provide valuable programs and services to our residents. In 2019 and 2020, Big Lakes County approved over \$100,000 as part of our Capital Project Grant program. Big Lakes County also accepts applications for our Operating Grant to help offset annual operating costs.

Clean Farms Collection Update

Attention farmers! Between the fall of 2022 and 2024, the <23L container collection program will undergo a gradual change that will align it with other provinces, enabling farmers to bring back these containers to their local retail outlets. Clean

Farms is also conducting a collection of unwanted pesticides and old livestock/equine medications at the St. Isadore Co-op.
