If caught illegally dumping waste, residents can face fines. If you witness someone dumping illegally, write down as much information as you can and report it to Big Lakes County.

How to Detect Water Leaks

The best way to determine if you have a leak in your plumbing system, is by first checking your water meter. Make sure no water is being used inside or outside of your house.

- 1. Open the flap on the meter, flash a bright light on the face to activate, it will cycle through the current read and flow rate. Flow rate should be zero if no water is being used.
- 2. Or, you can also take a meter reading and wait 1 or 2 hours and take another meter reading (make sure no water is used during this time). If the reading has changed, you may have a leak.

If you will be away for an extended period of time, ensure that your inside valve is shut off!

Agricultural Services

Fence Line Spraying Program

Have you noticed the persistent Canada Thistle and Sow Thistle growing along the edges of your property adjacent to County Road allowances? These narrow strips of weeds, when left idle, are a major weed proliferation source to your croplands, and County Road allowances. They are often difficult and/or time consuming to control due to their proximity to fences, power poles, etc., and are often missed during field spraying operations.

The County has recognized this situation and will provide to landowners, the spraying of these transition zones under the Fence Line Spraying Program. The requested areas will be incorporated into our annual spray rotation, free of charge. To sign up for this program, landowners simply need to complete a form identifying the lands where spraying is required. The spray request forms are available at the County administration offices, and on our website under

forms. Once completed, forms can be submitted online or at our administration offices. If you have any questions please contact our Agricultural Services Department.

Rural Renewal Stream


