While the County's current financial picture is predicting a surplus of approximately \$2.35M, this is directly attributed to several factors, including:

- 1) Higher than anticipated water/wastewater revenues,
- 2) Increased investment revenues, and
- 3) Unanticipated grant payments from other levels of government.

Clean

Reminder!

Help keep our County and Waste Transfer sites clean!

A friendly reminder to please maintain the cleanliness of our waste transfer sites. Let's work together to ensure they remain clean and user-friendly for all community members. Proper disposal and a little extra care go a long way in preserving our community's environment!

Bylaw

A reminder to Big Lakes County residents regarding the use of Off-Highway Vehicles. Anyone that is at least fourteen years old and the holder of a valid Class 7 Operator's Licence may operate an off-highway vehicle on a highway that is maintained by the County, subject however to the following conditions:

- (1) Without restricting the generality of the foregoing, the provisions of the Traffic Safety Act and its regulations shall apply to the operation of off-highway vehicles on County highways.
- (2) Operators of off-highway vehicles on County highways shall travel on the extreme right-hand side of the road or in the ditch, in the same direction as the motoring public and shall travel single file at all times.
- (3) The maximum speed at which off-highway vehicles are permitted to travel on County highways is 50 kilometers per hour.
- (4) No person shall operate an off-highway vehicle within the territorial limits of any Hamlet within the County at a speed in excess of 30 kilometers per hour.
- (5) The hours of operating an off-highway vehicle on a County highway within a Hamlet shall be restricted to the period of time between 8:00 a.m. and 11:00 p.m. in any one day.
- (6) No person shall operate an off-highway vehicle on any schoolyard, any posted recreation area or playgrounds within the County.
- (7) No person shall operate an off-highway vehicle unless the said operator is wearing a safety helmet securely attached on his or her head.
- (8) No person shall ride as a passenger on an off-highway vehicle unless the said person is wearing a safety helmet securely attached on his or her head.
- (9) No person shall operate an off-highway vehicle on any County highway where signs prohibit.
- (10) No person shall allow an off-highway vehicle to be left running and unattended.
- (11) No person shall operate or be a passenger on an off-highway vehicle where the number of persons on the off-highway vehicle exceeds the number of persons that the off-highway vehicle is designed to carry.
