Big Lakes County Department Highlights

Snowplow Agreements

Big Lakes County is still accepting applications for Private Driveway Snowplowing from County residents for the 2024 winter season. Agreements can be found on our website and submitted to a County office.

The County is responsible for maintaining approximately 1,300 km of rural roads. During heavy snowfalls, the highest priority is to maintain the key road network. The task is made more difficult when snow is plowed onto roadways.

When snow is pushed onto the road, it can lead to the formation of a snow/ice ridge on the road, posing significant potential hazards, can cause damage to vehicles and increases likelihood of injury.

Additionally, this activity is not permitted under the "General Traffic Bylaw", is a danger for all motorists, causes gravel loss, is a substantial personal liability and creates potential drainage problems.

Please do not push snow across the road onto public roadways or into the opposite ditch while completing snow removal on private driveways and approaches.

2023 Alberta Wildfires: Support for Households

As part of our ongoing assistance to impacted communities, the Canadian Red Cross has launched the **Support for Households** program. This program offers personalized recovery support and financial incentives for a range of mitigative and maintenance activities to help households impacted by the 2023 Alberta Wildfires.

Personalized Recovery Support

Personalized recovery support is available to those with a primary residence that was destroyed or saw major damage as a result of the 2023 Alberta Wildfires. It is available to those who are homeowners, tenants, or live in a community-owned home.

The Canadian Red Cross teams work directly with impacted people to help them navigate their recovery journey and access available community resources and support.

Residential Mitigation Incentives

Support for residential mitigation and maintenance activities is available to Albertans with a primary residence that was not damaged, or that incurred minor damage, in a community that was under an evacuation order or alert during the 2023 Alberta Wildfires.

These activities reduce the risk of wildfire spread around your home and can range from small, short-term tasks you can complete independently to larger, long-term projects that require the support of a professional.

Please Note: Transfer Stations are closed Christmas Day. The Regional Landfill is closed Christmas Day, Boxing Day, New Years Day, and Easter Sunday.

Reminders

Help keep our County clean by properly securing your load and bringing your waste to a Transfer Station or Regional Landfill.

If caught illegally dumping waste, residents can face fines. If you witness someone dumping illegally, write down as much information as you can and report it to Big Lakes County.

2023 Tax Penalties

If you still need to pay your property taxes, please pay them before January 31, 2024! A 14.5% penalty will be issued on February 1, 2024, for any balances still owing.

If you would like to sign up for our Tax Installment Payment Plan (TIPP) it is not too late. TIPP allows you to pay your property taxes on a monthly basis instead of one payment in June. TIPP makes budgeting easier and eliminates the risk of late payment penalties. Call our Tax and Assessment Clerk at 780-523-5955 for more information.
